

## **DEXUS STANDARD COMPETITION TERMS & CONDITIONS**

### **QV MELBOURNE BLACK FRIDAY GIFT CARD REWARD FOR SPEND Terms and Conditions**

1. These terms and conditions are for all entrants who enter the QV Melbourne Black Friday Gift Card Reward for Spend Centre Promotion ("Promotion"). Participation in this Promotion is deemed acceptance of these Terms and Conditions.
2. The "Promoter" is Dexus Funds Management Limited (ABN: 24 060 920 783) as Trustee for Dexus CPA Trust AND Victoria Square QV Investments Pty Limited. The address is QV, Cnr Lonsdale and Swanston Streets, Melbourne, VIC 3000.

#### **ELIGIBILITY**

3. Subject to condition 3, this Promotion is only open to Australian residents aged 18 years or over. Persons under 18 years of age must be accompanied by an adult.
4.
